04/04/23 Public Speaking

-A member of the public advised of the deadline for the local Minerals Plan consultation (2nd May) and urged the Parish Council to remain updated on the impact of this plan both for the Parish and more widely and advised of the work being done by Derbyshire Climate Coalition and CPRE. Documents and letters will be forwarded to the Parish Council for information. The Parish Council advised that whilst the plan does not affect Doveridge directly, support has been offered to Sudbury Parish Council with any representations they make.

- -A member of the public referred to the Derbyshire Dales Local Plan and commented that developers in the district don't appear to be honouring the plan by building zero carbon houses. The Parish Council advised that the Local Plan is being reviewed by DDDC and this must be completed by end of 2024, with a draft that will go to public consultation at the end of 2023. The Parish Council are awaiting publication of the DDDC draft Local Plan in order to complete the review the Doveridge Parish Council Neighbourhood Plan.
- -A member of the public urged the Parish Council to attend Climate Training. Sessions can be run locally with a minimum of 20 councillors. The member of the public will canvass other local councils to gauge interest and arrange an event at the Village Hall.
- -Cllr Goulden suggested that the Parish Council could fund the hire of the Village Hall for the above event.
